 - (b) Three copies of the application
- (4) Within 10 working days after filing this application with the District Licensing Agency, the applicant is required to give public notice of the application in Form 1. The notice must be published in a newspaper or newspapers circulating in the district and nominated by the Secretary of the District Licensing Agency, with not less than five days and not more than 10 days between the two dates of publication.
- (5) Within 10 working days after filing this application with the District Licensing Agency, the applicant must ensure that notice of the application in Form 1A is attached in a conspicuous place on or adjacent to the site to which the application relates (unless the Secretary of the District Licensing Agency agrees that it is impracticable or unreasonable to do so).
