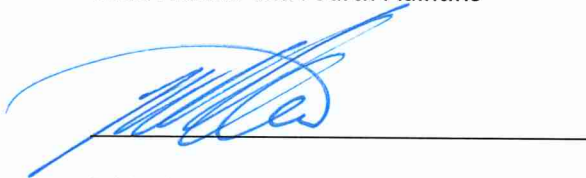
This document notifies you that—
